**Rehearsal Information for Company members:**

Fall 2018- Starting September 4<sup>th</sup> through the end of the dance season (May 21<sup>st</sup> last class)

**Tuition and Fees for Company dancers:**

Fall Rehearsal 2018 fees (9 months of rehearsals this season)

- total \$387 (can be paid in advance at fall registration or can be paid monthly - \$43/month)

Costume Fee- \$100 total due per dancer

(Costume fee covers uniform that will be worn to all performances and accessories)

Costume Fee is due by August 1<sup>st</sup>, 2018.

**Requirements to join the Company:**

- Dancer must be a registered Pre Pro Company dancer at CMC for the 2018-2019 dance season
- Dancer must have attended the required 3 technique classes each month for the 2017-2018 dance season
- Dancer must be accepted into the Company based on their ability to meet the technique requirements
- Dancer is allowed to miss only one performance out of 4 total.
- Rehearsal attendance policy- dancer is allowed to miss no more than 4 rehearsals September - May, TARDINESS COUNTS - 2 tardies equals one absence
- TECHNIQUE REQUIREMENTS: clean double pirouette, turning leaps, side leaps / center leap, can execute a clean leaps and turn combo at an intermediate to advanced level, 2 flat splits, can execute a la seconde or fuette turns, shows excellent performance ability.
